1	Business is a matter of faith and online business is one step ahead of that, hence we advise you to maintain honesty and discipline in your profession. We advise not to provide any incorrect information or product to the customers.
2	The company holds the right to change it's policies for the betterment of the company and its associates in majority, without any prior intimation to its associates. However the changed policy will be circulated among its associates for the implementation purpose. Please visit https://klikinfotech.com/tc/ for latest terms & conditions.
3	From time to time, the company will provide necessary trainings for the development of its associates. The associates are requested to follow the same for their personal development and leading to development of the company. Since the company believes in the concept or group working and growth, the associates are requested to co-ordinate with the same and grow.
4	The company will try its level best to grow the business of the associates, however if for some reason, the associate is not getting their expected growth, then the associate shall not hold the company responsible for the degrowth.
5	Associates are requested to have patience in the business, as business is a matter of time, and it takes time to grow a business, nothing happens overnight.
6	In case any associate has any kind of issues related to profession, we request them to share with us. We will be happy to help them.
7	In case of any disputes or issues, we advise associates to solve the issues with mutual conversations and meetings, instead of looking for legal advisories at first attempt.
8	For people who are availing facility of our payment gateway , the calculation of revenue earned for a month will be done from 20th date of previous month to 19th date of current month, and the payable amount will be transferred to their account from 1st to 7th day of current month.
9	For Rental Purpose a month is considered from the 20th date of a month to 19th date of next month. Hence the rentals needs to be paid prior to 20th date of every month. In case of new joinings, no matter on which date they join, but their rentals will be considered from 20th day of the coming month. And the excess days will be considered as Free Days.
10	The rentals and site maintenance charges are subjected to hike once in a year (a commercial year states from April to March), analyzing on the inflation and market trend, which will be intimated to the associates, and associates are requested to follow the same.
11	People who are availing pay as you go scheme , 20% of your total monthly transaction will be deducted from your total monthly revenue earned and rest 80% of total transaction will be transferred to your account every month.
12	For People who are not availing facility of our payment gateway , we are not responsible for their deals or money transfers, we are only responsible for promotion & maintenance of their site. However if required for solving any critical issue, we may interfere and try solving the issue.
13	Sellers are advised not to supply incorrect product to the customers in any condition. And in case of any issue contact us, we will resolve the issue together.
14	In case the consignment is not received by the customer we have to refund the payment to the customer, and hence it will be deducted from your account.
15	If the consignment is rejected by the customer for some valid reason, then we have to return back the product amount + the courier charge to the customer, and hence the amount will be deducted from your account.
16	For people who are availing facility of our payment gateway , Your payment will not be released until we receive confirmation of delivery from customer.
17	Since the transaction system is complex and centralized, hence we advice the associates not put your contact details on the consignment unless we tell you to do so.
18	If we find you publishing incorrect information or misleading customers on our website, we hold the right to remove your content and links from our sites. And you should not have any objection to that.
19	If somehow we find that you are not following the policies of the company, we hold the rights to terminate our agreement and remove your link and content from our site.
20	In case of termination of associates for some reason, the company will not be responsible to return any amount to the associate, however if there is any harm or loss done by the associate to the company, the company shall take necessary actions to recover the amount from the associate.
21	Associates are provided a portal (web space) on our websites, in exchange of rent or charges and hence, associates are requested to pay their agreed rentals or charges on time, otherwise the company has the right to remove their content and links from the website without any prior intimation to the associate.
22	If for some reason the content and links of associates are removed from the website, and re-registration happens with the associate, then the associate has to follow the rules of rejoining again and also pay the rejoining amount.
23	In case of rejoining of associate we have to remake their portal again from the beginning, hence we cannot assure the associates that we can recover the history, however we will try our level best to help the rejoining associate, so that they can get their deleted portal back. Hence to get rid of these hassles, associates are requested to pay their agreed rentals on time.
